



Basketball Wales Privacy Notice

Basketball Wales of, 5 Cwrt Rebecca, Pontarddulais, Swansea, SA4 8JL is the data controller for the purpose of the Data Protection Act 1998 and any amending and replacement legislation from time to time in force, the General Data Protection Regulation and any and all domestic legislation implementing the Regulation into English law.

We shall process the personal data (including sensitive personal data) that we collect from you in accordance with our Privacy Policy. In particular, we will use information we hold about you for the purposes of carrying out any of our obligations under a contract between you and us, for example processing your application to become a member of Basketball Wales, to provide you with further information on selected goods and services we (and any selected third parties) may offer where you have consented to receiving marketing materials from us, to notify you of any changes to the services or products under any agreement between us and in order to comply with our legal and regulatory obligations.

Example of processing based on legitimate interest that the entity carries out.

We will collect and retain information about you during your use of our Website, including information you give us. For example, where you contact us or subscribe to our newsletter, we will collect and retain the contact information you provide to us. We will need to process that personal information in order to respond to your query or sign you up as a member and have a legitimate interest to hold that information in order to respond any questions you may have and to provide you with our newsletter. We will also retain and use information we collect about you, for communication and marketing preferences.

We need to process the information we collect about you in order to manage your membership and our database and have a legitimate interest to hold that information in order to allow you to access and use your account and to make sure that we only send you communications that you want to receive. This information will be held by us for until the contract between us has ended. Where you have consented to us processing for marketing purposes, we will only process your data in accordance with the terms of that consent. Where you apply to become a member of Basketball Wales we will collect and retain this personal information. We will be required to process your personal information to fulfil our contractual obligation to perform our contract with you, arrange games, tournaments, training and officials, and we have a legitimate interest in holding this personal information to inform you of any updates to our services or on any updates in relation to your membership. This information will be held by us whilst the contract between you and us remains in effect, and for 12 months following. Where you have consented to us processing for marketing purposes, we will only process your data in accordance with the terms of that consent.
